

**CONCORD CONSERVATION COMMISSION**  
**Trails Subcommittee Meeting**  
**April 14, 2021**

The committee was authorized to meet electronically due to COVID-19. Chair Rob Knight called the meeting to order and read the following statement:

**Agenda items**

1. Minutes of March 10<sup>th</sup> 2021 were accepted as presented.
2. New trail Updates:
  - a. An agreement has been signed with Bryce Lambert allowing the Cart Path trail to cross a corner of his property as part of the Back Woods Trail system. The map, signs and blazing need updating. The intern who is starting soon for the summer will be given the task of blazing this section with orange paint. The connector trail from the Yellow Trail to the BWT is to have

yellow and orange blazes. In addition, now that the BWT is official and complete, the map at the Fisk Hill Rd entrance kiosk needs updating. Five Rivers Land Trust has funds from an endowment that can fund the update. Finally, this new trail section needs either a culvert or plank walk over a wet area as well as removal of a tree hung up on other trees. Ron will enlist help for this.

- b. Following a meeting with Don Ross, Ron has flagged an alternative route for the Swope Connector Trail to avoid the farm operations at Ross View Farm. The trail will go south through the Crosby property, then along the edge of Rossview Farm property. The Rosses will still prohibit horses and mountain bikes on the Ross property. Rebecca Ross joined the discussion to say that if the new Swope Connector trail went satisfactorily, they would be willing to discuss rerouting the WEFT and access points of entry onto the Ross property. The city is bearing the cost of these changes to avoid continuing conflict over this easement. Rob Talmadge expressed thanks to the Ross family for cooperating in working out a solution.
  - c. At Knowlton Woods, the west side trail is almost complete. Mike Bowser is adding some switchbacks to the east trail and plans to separate bikers and hikers for a section where bikes will be going fast. Ron K would like to see and approve any reroute. The parking lot remains to be done.
3. Trail Maintenance and Reporting:
- a. Rob Knight reports that trail reports are coming in from stewards for the spring trail check. He has removed “muddy trail” signs. Judy Weatherbee will do so also at Oak Hill.
  - b. Ron has removed downed trees from the Carter Hill/Swope connector, Batchelder Mill, Horse Hill trails, and the Swope-Winant connector.
  - c. Ben Stephenson reported someone is placing sticks and brush on a rock formation that bikers like to use just off the Krupa Loop trail which is a hazard. No one on the sub-committee is aware of this. Ben will keep an eye on it.
  - d. Ben also notes that confusion reigns at the top of Oak Hill as to where it is legal to walk and bike. Ron K had placed a “trail closed” sign at a trail that goes onto private land but it may have been removed. The only official city trail to and from the tower runs below a power line before entering the woods heading toward Shaker Rd. The city property line is blazed red and trail users need to avoid all private land on Oak Hill.
4. Rob Knight and Fran Philippe and anyone else interested will examine the question of a loop trail through the woods at Locke Rd. Meet there Wednesday April 21 at 9:00.
5. The summer intern, Cathy McComish, starts next week. She will do easement monitoring, update kiosks as needed, and work with Ron K.

Meeting adjourned at 6:20 pm. Next meeting will be on May 12 at 5:15.
